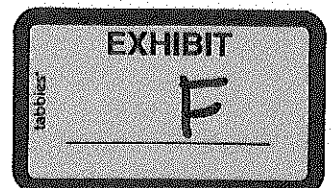
AFFIDAVIT OF FRED I. CHANATRY
